### Chalfont St Giles Tennis Club Terms & Conditions

## 1. Membership Period

The membership year is from 1<sup>st</sup> May until 30th April. The full membership fee is due when joining in any month between April and August. .

### 2. Late Joiners

Where a new member joins the club from 1<sup>st</sup> September the membership fee is reduced.

The fee charged is calculated on a monthly basis for the number of calendar months remaining in the membership year up until the 30<sup>th</sup> April.

## 3. Membership Categories

Membership categories are determined by age at 1st May of the membership year. Members will be required to provide evidence of their eligibility for non-standard membership categories. Where suitable evidence has not been provided, the Club reserves the right to charge full members rate.

# 4. Membership Renewal

Membership fees are due on the 30<sup>th</sup> April and must be paid by 15<sup>th</sup> May. Payments by existing members received after 15<sup>th</sup> May will be subject to an additional £10 late payment fee.

#### 5. Cancellation and Refunds

Membership fees once paid are not refundable. Any exceptions are at the management Committee's discretion

#### 6. Consents

By enrolling as a Club Member, or enrolling a child as a junior member, the individual is giving consent to Chalfont St Giles Tennis Club to:

 Hold personal details of the member for the purpose of the club business including establishing or maintaining membership and the provision of membership services to the member. Note: We will not disclose member details to third parties excluding other club members e.g. for organizing matches, internal tournaments and similar events

#### 7. Medical details

Parents/carers are required to provide, and update as appropriate, emergency name and contact details as well as information on medical/behavioural conditions for any junior memberships they register with the club.

## 8. Misplacement or theft of belongs

Chalfont St Giles Tennis Club is not liable for any misplacement or theft of belongings whilst within or outside the facility.

#### 9. Wimbledon Ballot

Members 9 years and over are entitled to enter the LTA ballot for Wimbledon tickets if they meet the following criteria:

- Have paid their current year's membership fees
- Hold an active Affiliated British Tennis membership (BTM)
- Have linked Chalfont S Giles Tennis Club as a venue to their BTM record
- Meet any other conditions published by the LTA for the current year's ballot (e.g. opt in requirements) If successful in the ballot, purchased tickets cannot be transferred or sold.

- Free Group Junior Nights with coaching tips & organised games during the summer term
- Discounted individual coaching rates (non-members booking an individual lesson with a club coach are required to pay an additional visitor fee)
- Full members have court priority but Junior members can use courts if no full time members are waiting
- Opportunity to represent club in a junior team and play inter club matches
